Privacy Policy

Protecting your private information is our priority. This Privacy Policy applies to Mercury Business Services LLC (hereinafter, "Mercury"), and governs data collection and usage. By using the Mercury website, you consent to the data practices described in this Privacy Policy.

Collection of your Personal Information

In order to better provide you with the Mercury Services offered, Mercury may collect personally identifiable information from its customers, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number
- Employer
- Job Title
- Credit Information
- Shipment specifications, order details.

If you purchase Mercury's Services, we collect billing, ACH bank information, and/or credit card information as applicable. This information is used to complete a customer's purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain Services. Use of your Personal Information

Mercury collects and uses your personal information to operate and deliver the Services you have requested.

Mercury may also use your personally identifiable information to inform you of other products or Services available from Mercury and/or its affiliates.

Sharing Information with Third Parties

Mercury does not sell, rent, or lease its customer lists to third parties.

Mercury may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Mercury, and they are required to maintain the confidentiality of your information.

Mercury may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Mercury or the site; (b) protect and defend the rights or property of Mercury; and/or (c) act under exigent circumstances to protect the personal safety of users of Mercury, or the public.

Tracking User Behavior

Mercury may keep track of the websites and pages our users visit within Mercury, in order to determine what Mercury services are the most popular. This data is used to deliver customized content and advertising within Mercury to customers whose behavior indicates that they are interested in a particular subject area.

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by Mercury. This information can include: your IP address, browser type, domain names, access times and referring website addresses. Use of Cookies

uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.
